Nuclear

The Organization addresses nuclear waste issues by harnessing the power of grassroots advocates, educating the public on the technical science behind the hazards of nuclear waste, and watchdogging corporations that profit from it.

This year HEAL Utah spent significant time and resources in opposition to a financially risky, unsafe and unnecessary nuclear project proposal that would leave small Utah cities in a precarious economic position. Sponsored by the Utah Associated Municipal Power Systems (UAMPS), this project, is known by its greenwashed moniker- the Carbon Free Power Project.

We were successful in getting eight of the largest municipalities who had committed to this project to withdraw and two others to reduce their subscription. In addition to our work opposing this misguided project, we remain committed to ensuring that state laws and public policies protect Utahns from radioactive waste.

- The creation of a committee to create rules and guidelines for a Voluntary Home Energy Information Pilot Program that will educate homeowners and sellers on home energy use. Included \$50,000 in one-time funding for the program.
- Clarification and technical changes to definitions in the state's pre-existing commercial property assessed clean energy (C-PACE) program.
- The creation of the Outdoor Adventure Commission which will lead strategic planning and recommendations on the state's outdoor recreation opportunities.

Sweet Streets

Sweet Streets was founded in 2020 by a team of three that worked to begin brand-building on an advocacy group that would work to watchdog for opportunities to make streets in Salt Lake City safer and more connected for people traveling outside of cars. Transportation is the No. 1 source of particulate matter in the Salt Lake Valley, and the group created a mission and guiding principles to lead the organization into the future.

HEAL recognized the Sweet Streets concept - particularly its smart growth, city-building component and positive impact on the climate - as affiliated with its own mission and agreed to act as fiscal sponsor for Sweet Streets.

In addition to formally organizing and forming a board toward the end of

2020, Sweet Streets effectively advocated for the creation of safe bike lanes and slower speeds on 1700 South in Ballpark; creating the first-ever bike lanes next to Liberty Park on 500 East; submitted applications for funding for a neighborhood byway connecting three neighborhoods and four schools with new crossings across two dangerous safe roads; created several short-, medium and long-term campaigns; began forming allyships with affiliated groups; created branding; and expanded our reach through emails and social media.
